CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

1. **Scope of Work:**

- a. Bush (uprooted) and vegetation clearing on the surface, slope, and, the edges of the drainage channel to eliminate hibernating site for land or water dangerous animals as well as hiding sites for criminals.
- b. Grass cutting to be not more than 100mm above the ground
- c. Removal of natural stream pollutants and foreign objects to unblock normal flow.
- d. No protected tree species beyond 1.5m from the stormwater edge shall be destroyed.
- e. Loading and the disposal of debris, trash and sedimentation particles.
- f. Area to each site may not exceed extent provided in Table 2 below.

NB: All required work shall be executed strictly using excavators and tipper trucks. No alternative equipment or manual methods will be permitted unless otherwise approved in writing by the Employer.
